Entry

2. The “**Competition**”: Participants are invited to collect a Sure Go Wild Gorillas colouring sheet from the Sure shop at 36 King Street, St. Helier, Jersey, JE3 2AP, and come up with their own colouring creation.
3. Sure will appoint its Go Wild Gorilla artist, Maria Tarrant, to judge and select the best colouring creations on a monthly basis on the following dates:
 - Tuesday 27th August 2019;
 - Tuesday 24th September 2019; and
 - Tuesday 15th October 2019.

The three winning colouring creations will be uploaded across Sure’s social media channels.

4. The Participant’s parent/legal guardian does not need to be a Sure customer or a resident of Jersey to enter into this Competition.
5. No purchase is necessary.
6. By entering into this Competition, the parent/legal guardian of the participant is agreeing to be bound by these terms and conditions.

14. Prizes are subject to availability and Sure reserves the right to substitute any prize with another of equivalent or greater value without giving notice.
15. Once a prize has been won, participants are no longer eligible to win subsequent prizes in this Competition.

Winners

16. The winners of this Competition will be selected by Maria Tarrant, Sure's appointed Go Wild Gorilla artist, on the dates mentioned in paragraph 3 above, and will be announced on Sure's Facebook, Instagram and Twitter pages. There will be three winners in total.
17. The parent/legal guardian of the winners will be contacted by phone using the details provided on the colouring sheet. Sure will be advised by the parent/legal guardian as to where to send the prize to or whether it will be collected from the Sure shop. Sure do not take any responsibility for prizes sent and lost in the post.
18. Sure will make reasonable efforts to contact the winner's parent/legal guardian by phone and notify them of the prize and to agree how to claim the prize.
